

Declaration of Earthly Occupancy

I, the undersigned Declarant, am of lawful age and sound mind, am competent for testifying as a first-hand witness, and am telling the truth, voluntarily relating the following first hand knowledge of the facts and stating that these facts are true and represent the best of my knowledge.

I was delivered from my mother's womb on April 24th, in the year of the Common Era 1948 in **Brooklyn, New York City, on the New York Commonwealth**, one of these several republics uniting America, neither within any federal district, nor within any territory or possession of any federal district. My political stand is that of a Judicial Power Occupant on the **Utah** republic, and I am thereby claiming all the Rights, privileges, and immunities recognized in the Constitution for the **Utah** republic, which is a binding contract upon the government commonly known as the **STATE OF UTAH CORPORATION** and enforceable in the courts under the statute of frauds.

This Affidavit of Occupancy functions as a NOTICE in compliance with 15 Statutes at Large, Chapter 249 (Section 1), July 27, 1868 and serves as notice upon all government employees and private entities that the undersigned man is legally and lawfully expatriated out of the jurisdiction of the United States (USCORP), a federal corporation.

By virtue of being a Sovereign, Judicial Power Occupant on the soil in the portion of the continent of North America commonly known as **Utah**, I am also a Judicial Power Occupant of these united states of America and empowered with all of the Rights, privileges, and immunities recognized and secured at the first **Ten Amendments to the Constitution for the United States of America**, which Constitution is a binding contract upon the government of the United States (USCORP) and is enforceable in the courts under the statute of frauds.

I am not, nor have I ever been a citizen or subject of the United States (USCORP), nor any of them, as contemplated at the so-called fourteenth amendment to the Constitution of the United States.

I am not, nor have I ever knowingly and voluntarily been a resident neither of the United States (USCORP) nor of any political subdivision within the United States, including but not limited to the STATE OF UTAH CORPORATION.
